



College Representation, Pathway and Extracurricular Activities Policy

ALL SAINTS'

Rationale

The College is committed to providing an opportunity for students to participate in College Representation, pathway and extracurricular activities outside of the core curriculum. These opportunities provide the opportunity for students to participate in activities outside of the classroom.

Aim

The aim of this policy is to outline the College requirements for students to participate in a wide range of representation, pathway and extracurricular activities.

The following experiences identified below are referred to as 'College Representation, pathway and extracurricular activities.' These activities include, but are not limited to:

- Sport
- Performing Arts.
- Academics.
- Excursions, incursions and camps.
- Leadership and mentoring.
- Ceremonial and community participation.

Curriculum based events, mandatory excursions, field trips or cohort incursions at no cost are not exempt from this policy.

Implementation

- It is the College's decision what representative, pathways and extracurricular events the College will be involved in over a 12-month period.
- Staff will advertise what extracurricular activities are available, and, if applicable, how to trial for a team and individual selection, with additional costs involved.
- Students will be responsible for making a commitment to audition and trial for teams and individual representation.
- College Staff have the final decision which students are selected to represent the College.
- Students selected must be available for the events, practices, rehearsals, pay costs involved and provide relevant equipment.
- Students must be available on the day/night/weekend to represent the College.

Eligibility for participation

- Student behaviour and attitude must be positive, enthusiastic and follow college expectations of behaviour to be eligible to participate in college representation and extracurricular activities.
- Student attire must be as directed, for College representation, pathway and extracurricular activities.
- Students must have a level of attendance that meets Diocesan targets.
- Students and families must abide by sport and extracurricular rules, instructions, codes of conduct and regulations as directed by sporting affiliations, officials, College staff and instructors.
- All decisions, (including selections and approvals), instructions by college staff, officials, event organisers and venue staff are final and must be adhered to by students and families.
- Concerns about behaviour will be communicated to parents and the student. This may result in the student being ineligible for representation and participation in representation and extracurricular activities to be reviewed termly.
- Parents and Carers must be supportive of college decisions around college and other pathway opportunities and extracurricular activities and uphold the Community Code of Conduct.
- For edibility for participation in any activities outside the core curriculum, College fees must be up-to-date or following a commitment to pay in accordance with any agreements arranged with the College per calendar year.
- Non-compliance with eligibility outlined in this policy may deem a student ineligible for future participation in College and other pathway opportunities as well as extracurricular activities.

Budget

Selected representative and extracurricular activities are covered within tuition fees whilst others will require an additional payment.

Evaluation

This policy will be reviewed every three years or more often if changes are required.
